ORDINANCE NO. 10-2018

AN ORDINANCE AMENDING CHAPTER 9: “SCHEDULE OF FEES” OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF ALLENTOWN TO CLARIFY CHARGES FOR RETURNED PAYMENTS.

BE IT ORDAINED by the Mayor and Council of the Borough of Allentown, County of Monmouth, State of New Jersey, that Chapter 9: “Schedule of Fees” of the Borough’s Revised General Ordinances is hereby amended as follows (~~stricken text~~ indicates deletions, underlined text indicates additions):

SUBSECTION 9-1, entitled “Administration Fees”, shall be amended as follows:

Copy Fees:	\$0.05/page (8.5 by 11 inches)
	\$0.07/page (8.5 by 14 inches)
	\$0.10/page (11 x 17 inches)
Notary Fee: Nonresident/ Non-Borough Business	\$ 2.00
Certified Copy: Vital Statistic Record	\$ 10.00
Liability and Assessment Search Fee	\$ 10.00
Liability and Assessment Continuation Search	\$ 2.00
Duplicate Tax Bill	\$ 5.00
Duplicate Tax Sale Certificate	\$100.00
Tax Search	\$ 10.00
Tax Address Listing	\$ 10.00
Address Labels (complete set)	\$ 20.00
Postage Fees	Actual cost of postage
Returned Check Payment Fee (Any returned payment, including credit card, e-pay, debit, check, etc.)	\$ 40.00
"White Goods" Pick up Fee (washer, dryer, refrigerator, etc.)	\$ 35.00/item

BE IT FURTHER ORDAINED by Mayor and Council that should any section, paragraph, sentence, clause, or phase of this ordinance be declared unconstitutional or invalid for any reason, the remaining portion of this ordinance shall not be affected thereby and shall remain in full force and effect, and to that end the provisions of this ordinance are hereby declared to be severable.

BE IT FURTHER ORDAINED by Mayor and Council that all ordinances or parts of ordinances inconsistent with this amending ordinance are hereby repealed to the extent of their inconsistencies only.


BE IT FURTHER ORDAINED by Mayor and Council that this ordinance shall be in full force and take effect twenty (20) days after final passage and publication, as required by law.
