Call to Order by Chairperson Craig Rondinone at 7:05pm and the following statement was read

1. Salute to Flag

  - a. Was officially approved by all present, had been email approved previously.
7. Historic Allentown 5K Update (Sept 25<sup>th</sup>)
  - a. We need to get the course to assist with the website and forms (M Drennan)
  - b. Goal is to get the website up within the week.
    - i. Course can be certified for a price ~\$300
    - ii. The sign-up site can be set-up with only partial information.
    - iii. Bill to provide some language for the Covid 19
  - c. Will be Hybrid(Virtual and Live)
    - i. Suggestion with only a minimum price difference for virtual.
  - d. Live Races: Reduce touch points –1) no same day sign-up, 2) start would be in waves – 6 ft by side and 6 ft behind, 3) t-shirts and bibs laid out on the table 4) mask not required on the course 5) no water stops/request they bring water 6) start and finish suggest should be in the same place (or near each other) and 7) awards are mailed
