ORDINANCE NO. 02-2024

AN ORDINANCE AMENDING CHAPTER 2: "ADMINISTRATION" OF THE BOROUGH'S REVISED GENERAL ORDINANCES TO MODIFY SUBSECTION 2-51.2: "MEMBERSHIP; QUALIFICATIONS; APPOINTMENT; TERM OF OFFICE" WITHIN SECTION 2-51: "GREEN TEAM ADVISORY COMMITTEE" TO PROVIDE FOR ADDITIONAL MEMBERS OF THE GREEN TEAM ADVISORY COMMITTEE.

BE IT ORDAINED by the Mayor and Council of the Borough of Allentown, County of Monmouth, State of New Jersey, that Chapter 2: "Administration" of the Borough's Revised General Ordinances is hereby amended as follows (~~stricken text~~ indicates deletions, underlined text indicates additions):

ARTICLE IV: "BOARDS, COMMITTEES AND COMMISSIONS"

§ 2-51 GREEN TEAM ADVISORY COMMITTEE.

* * *

§ 2-51.2 Members; Qualifications; Appointment; Term of Office.

- a. The Green Team Advisory Committee shall consist of ~~11~~ thirteen (13) members, all of whom shall be either:
 - 1. A resident of the Borough; or
 - 2. The owner or operator of a business within the Borough; or
 - 3. An employee, official, or contractor of the Borough.

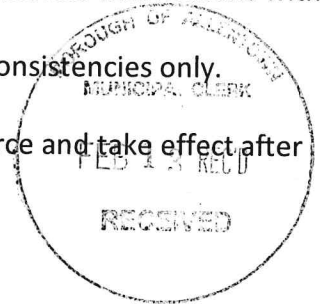
- b. The Green Team Advisory Committee membership shall be comprised as follows:
 - 1. The Borough ~~Clerk~~ Administrator;
 - 2. The Borough Recycling Coordinator;
 - 3. The Mayor;
 - 4. One member of the Borough Council;
 - 5. Two members of the Environmental Commission;
 - 6. Two members of the Shade Tree Commission;

- 7. One member of the Economic Development Commission;
 - 8. One member of the Board of Recreation Commissioners; ~~and~~
 - 9. One member of the Planning Board; and
 - 10. Two members, both of whom shall be a resident of the Borough and/or the owner or operator of a business within the Borough.
- c. All members shall be appointed for a term of one year, which appointments shall run from January 1 of the year of appointment. All members shall be appointed by the Mayor with the advice and consent of the Borough Council, except for the Member of the Borough Council, who shall be appointed by a majority vote of the entire governing body.
- d. All appointments to fill vacancies shall be promptly filled by appointment by the Mayor with the advice and consent of the Borough Council for the unexpired term in the same way the original appointments were made. If the Mayor shall fail to make a nomination within thirty days of the occurrence of a vacancy, the Borough Council shall fill the vacancy by simple majority vote of the members present at its next meeting following the expiration of the aforementioned thirty-day period.

BE IT FURTHER ORDAINED that should any section, paragraph, sentence, clause, or phase of this ordinance be declared unconstitutional or invalid for any reason, the remaining portion of this ordinance shall not be affected thereby and shall remain in full force and effect, and to that end the provisions of this ordinance are hereby declared to be severable.

BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent with this amending ordinance are hereby repealed to the extent of their inconsistencies only.

BE IT FURTHER ORDAINED that this ordinance shall be in full force and take effect after final passage and publication according to law.
